3 airlines to merge with Air India

Mumbai: Tata Sons is gearing up for the expansion and strengthening of Air India, which it acquired a few days ago. Tata Sons has decided to merge three companies namely Airlines Vistara, Air Asia and Air India Express into Air India. Sources informed that the process has started and an official announcement will be made soon. If this plan of Tata Sons is successful, Air India will become the second largest airline in the country in terms of fleet and market share. Singapore Airlines is a partner of the Tata Group. Tata is in talks with Singapore Airlines about this. Tatas have discussed this with Singapore Airlines and have agreed to merge Vistara with Tata. Singapore Airlines is an expansion partner of the Tata Group and after this merger, Tata Singapore Airlines, which operates the expansion, may merge with Air India. Air India will be a low cost full service airline. An official announcement about this can be made within a week. Both airlines may resume commercial operations soon. But it may take more than a year to start working as an organization, sources said. Vistara and Air India may resume commercial operations soon. However, Tata Sons and Vistara have not given any official comment on this as of now.

have agreed to merge Vistara with Tata. Singapore Airlines is an expansion partner of the Tata Group and after this merger, Tata Singapore Airlines, which operates the expansion, may merge with Air India. Air India will be a low cost full service airline. An official announcement about this can be made within a week. Both airlines may resume commercial operations soon. But it may take more than a year to start working as an organization, sources said. Vistara and Air India may resume commercial operations soon. However, Tata Sons and Vistara have not given any official comment on this as of now.

India raises 'hate crime' concerns with Canada after heritage Hindu temple defaced with anti-India graffiti

India raised the concern of 'hate crime' with Canadian authorities after a heritage Hindu temple was defaced with anti-India graffiti in Brampton.

New Delhi, India on Monday raised the matter of 'hate crime' with Canadian authorities after a prominent Hindu temple in Canada's Brampton was vandalised with anti-India graffiti. The act has caused outrage among the Indian community. Condemning the act of vandalism at Gauri Shankar Mandir, the Indian Consulate General in Toronto said that the defacing of the temple has deeply "hurt the sentiments" of the Indian community in Canada. "We strongly condemn the defacing of Gauri Shankar Mandir in Brampton, a symbol of Indian heritage, with anti-India graffiti. The hateful act of vandalism has deeply hurt the sentiments of the Indian community in Canada. We

have raised our concerns on the matter with Canadian authorities. The Indian mission wrote in its tweet. While the Canadian authorities are currently investigating the incident, Mayor of Brampton Patrick Brown has also condemned the incident of writing hate-filled messages directed towards India on the walls of the temple.

"The City of Brampton condemns the defacing of Gauri Shankar Mandir. This hateful act of vandalism has no place in our City or Country. I have raised my concerns over this hate crime with Chief Nishan Durainippan and Peel Regional Police. Everyone deserves to feel safe in their place of worship," said the city Mayor. Indian origin Member of Parliament in Canada, Chandra Arya, wrote in a tweet, "The attack of Gauri Shankar Mandir in Brampton is latest in attacks on Hindu temples in Canada by anti-Hindu and anti-India groups. From hatred on social media, now physical attacks on Hindu temples, what next? I call on govt at levels in Canada to start taking this seriously. This is the third such instance of 'hate crime' and act of vandalism recorded in Canada since last July.

Earthquake of 4.9 magnitude hits Andaman Sea

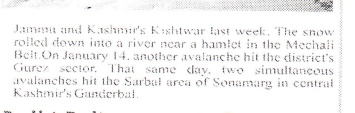
New Delhi. An earthquake hit the Andaman Sea in the Andaman and Nicobar islands on Tuesday, January 31. There were no reports of damage. An earthquake of 4.9 magnitude was recorded in the Andaman Sea, the National Center for Seismology said. According to the National Center for Seismology, the earthquake occurred around 3:40 am. It was 77 Km in depth as per the NCS Earthquake of Magnitude-4.9, Occurred on 31-01-2023, 00:15:40 IST, Lat: 12.60 & Long: 93.42, Depth: 77 Km, Location: Andaman Sea, India. The National Center for Seismology earlier on January 22, strong tremors were felt in Delhi, Uttar Pradesh and Uttarakhand, after an earthquake jolted Nepal. According to the National Centre for Seismology, an earthquake of magnitude 5.8 on the Richter scale jolted Delhi and other parts.

Two trucks collide, catch fire in Rajasthan; driver killed in blaze

New Delhi. The driver of a truck dived following his vehicle's collision with another truck in Rajasthan on Monday. The two trucks caught fire soon after the accident. The incident was reported from Patil's Rohat town in the state. While the driver of one truck managed to escape the flames, the other driver was reportedly stuck inside the dumper. His body was retrieved after fire department officials and police reached the spot. A video from the accident spot showed both trucks on fire. Several explosions were also heard. Meanwhile, traffic on the entire stretch of the road was affected and vehicular movement was halted until the spot was cleared.

Avalanche alert in Kishtwar, Poonch, other districts of Jammu & Kashmir

New Delhi. Avalanche with a high danger level has been predicted by the Jammu Kashmir Disaster Management Authority (JKDMA) on January 30. According to JKDMA, medium to danger level avalanches will likely occur above 1500 to 2500 m over the Bandipora, Ganderbal, Kupwara, Kulgam and Ramban districts of Jammu and Kashmir over the next 24 hours. "People living in these areas are advised to take precautions and avoid venturing in the avalanche prone areas," said the JKDMA. A massive avalanche hit



Jammu and Kashmir's Kishtwar last week. The snow rolled down into a river near a hamlet in the Meelahi Belt. On January 14, another avalanche hit the district's Gurez sector. That same day, two simultaneous avalanches hit the Sarbal area of Sonamarg in central Kashmir's Ganderbal.
